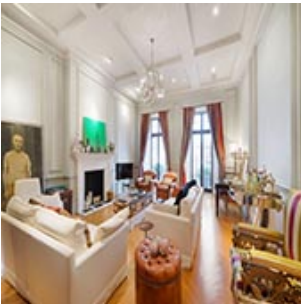

MARKET WATCH: LONDON PROPERTY PRICES

“We have hit the ground running this year in lettings, with some important properties achieving £4,000-£5,000 a week,” explains Charles Sheldon, Senior Sales Negotiator, Henry & James. “They are usually the kind of large family properties that are rented in September, at the start of the school year. Yet it shows the confidence people have in central London as a place to live and work. There is plenty of interest around and, when people compare us with Paris, where taxes are higher, London is more attractive.

“Sellers sometimes feel they should wait until the spring before putting their properties on the market, but this year I would advise them to put them on the market early. It is futile trying to predict the political future in any detail, but I am confident that there will be added interest in the year ahead.”

Halkin Place is a delightful little side street, just off Belgrave Square. It is hard to imagine a more convenient location, just a short walk from Knightsbridge and the King’s Road. And it is worthy of the location. This is a Grade II-listed town house, stucco-fronted, with the grand, high-ceilinged rooms that are associated with Belgravia at its best. 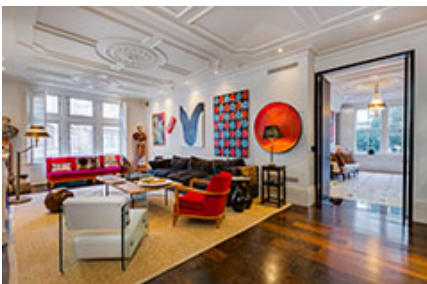
